REVOKING EXISTING REFERENDUM REVENUE AUTHORIZATION; APPROVING NEW AUTHORIZATION

The School Board of Independent School District No. 771 (Chokio-Alberta Public Schools), Minnesota, has proposed to revoke the school district's existing referendum revenue authorization of \$2,693.69 per pupil, and to replace that authorization with a new referendum revenue authorization of \$5,200 per pupil. The proposed referendum revenue authorization would be first levied in 2022 for taxes payable in 2023 and would be applicable for ten (10) years, unless otherwise revoked or reduced as provided by law.
